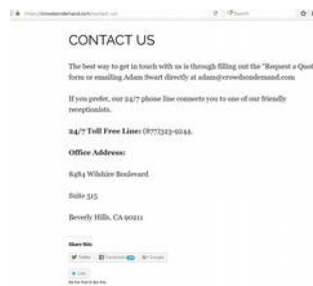

## [Gawker Media: Hypocrites vs. Douchebanoes](#)

In 2002, a failed British journalist named Nick Denton started *Gawker*, a bitchy gossip blog run out of his Manhattan apartment. Over 10 years later, *Gawker* and its sister sites have become the biggest names in clickbait “journalism,” pulling down millions of visitors a month and making its owner a millionaire several times over. The secret to Denton’s success? He took the aggressive, lynch mob mentality of British tabloids, which specialize in ruining people’s lives, and injected it into [America’s comparatively placid, Oprahfied media market](#).

In particular, *Gawker*, *Jezebel*, *Valleywag*, and their sister sites specialize in witch hunts: digital vigilantism against those who fail to keep up with leftist orthodoxy. [Geoffrey Miller](#), [Pax Dickinson](#), [Justine Tunney](#), [Violentacrez](#): the list of people whom *Gawker* has garroted for “racism” or “misogyny” could fill a phone book. With an army of Twitter twits behind it, Gawker Media truly is the moral majority of the left, instigating mob action against those who sin against the religion of *tolerance*. *Gawker*’s provocations are even encouraging real-world violence now, as *Valleywag*’s overfed man-baby of an editor Sam Biddle [eggs on attacks against San Francisco tech workers](#) from the safety of the East Coast.

For the past few months, 4chan has been engaged in a trolling operation against *Jezebel*, [posting pictures of rape and gore porn in the comments section](#). Despite the fact that these shocking and disgusting images are stressing out staffers to the point where they’re developing PTSD, Denton has steadfastly refused to do anything about the problem. *Jezebel*’s staff recently snapped and [posted an open letter on the site](#) demanding that Gawker Media do something, calling 4chan’s trolling “a very real and immediate threat to the mental health of *Jezebel*’s staff and readers.”

Fat chance of this happening, however. [As others have pointed out](#), Gawker Media’s business model depends on getting clicks; indeed, [their writers are paid according to how many page views their articles get](#). Since comments help drive traffic to websites, fighting 4chan’s rape porn trolling will reduce *Gawker*’s profitability. Not only that, [Google itself ranks web pages according to how many comments they have](#), as comments are extremely difficult to fake. Fewer comments means a lower page rank, which translates into less search traffic and less money for Denton to blow on exotic vacations with his boy-toy hubby. If Gawker Media was willing to testify in federal court as to [why they should be allowed to rip off their interns](#), you can bet your bottom peso that they aren’t going to do jack about this.

And there’s the punch line. Gawker Media, the company that gets people fired from their jobs for making “sexist” jokes, has been creating a hostile work environment for its women staffers for *months*. They’re the leftist equivalent of a priest who rails against homosexuality only to be caught molesting altar boys in the confessional booths. In staying silent on this for so long, Dodai Stewart, [Lindy West](#), and *Jezebel*’s other star employees have shown themselves to be frauds. They don’t care about feminism, “fat shaming,” or whatever cause they’re screeching about today; all they care about is money and power. And now we have the proof.

We shouldn’t be too surprised. For those too squeamish for war, social justice is the next best racket. If you’re an amoral hustler with no talent or job skills, just brand yourself an “activist” and you too can be raking in the Benjamins. Just ask Suey Park. She’s best known for [launching the #CancelColbert campaign](#) in response to a “racist” Tweet posted by Stephen Colbert ... [that was neither posted by him nor actually meant to be racist](#). As it turns out, Park is a professional activist [who makes her living from consultations and speaking engagements](#). By engineering bogus controversies such as #CancelColbert and [#NotMyChristianLeader](#), she gets free attention from the media, driving up demand for her services and making herself richer.

She’s far from the only example. Scratch a holier-than-thou social justice campaign and you’ll find oodles of cash at stake. Pax Dickinson, one of *Gawker*’s most notable victims, was the CTO

of *Business Insider*, [one of Gawker Media's biggest rivals](#). V. Stiviano, the mistress of L.A. Clippers owner Donald Sterling, was possibly pressured into releasing her "racist" tapes of the man by Magic Johnson, [who's been looking to wrest control of the Clippers from Sterling for years now](#). Morris Dees, founder of the Southern Poverty Law Center, [is worth millions of dollars](#). Clearly, nobody is going broke overestimating the credulity of the American public.

As Ryan Holiday wrote in his now-classic book [Trust Me, I'm Lying: Confessions of a Media Manipulator](#), this kind of chicanery has never been easier. With the Internet accelerating the news cycle to light speed, news organizations no longer have the ability to be slow and thorough. He who dies with the most clicks wins, and with sites like *Gawker* who make their bread off of clickbait, [every newspaper and TV station has to be equally sensational just to compete](#). Not that journalists have any interest in getting the story right, anyway: as I learned during my brief experience in J-school years ago, the current crop of young reporters are [committing plagiarism and fabrication](#) on a scale that makes Stephen Glass look like Ambrose Bierce.

And now the self-appointed commissars of the left are being hoisted by their own petards. Nick Denton himself once said that "[hypocrisy is the only modern sin](#)," which by his own logic makes him the Antichrist. I would have loved to have been a fly on the wall when West, Stewart, Erin Gloria Ryan and *Jezebel's* other staffers realized that their boss was treating them just as cruelly as they've treated every "misogynist" and "douche canoe" they've set out to destroy. Their meal ticket came with a poisoned chalice.

## Inside the Delightful Suicide of Gawker

### Good riddance.

In the history of giving a hostage to fortune, John Cook, a former editor of the former online poison party known as Gawker, merits a special place. He has this to say about his professional aims: “I wanted to write true things about bad people . . . being bad or obnoxious or cruel or unkind.” When enemies had been so identified, he says, “We could give ’em ‘what fer.’”

Unkind! Gawker saying its mission is to make war with the unkind is like the Queen of England decrying nepotism. Gawker’s very escutcheon was cruelty, obnoxiousness, unkindness. It published stories too nasty and sleazy for tabloids, and wrote them up with sophomoric zeal for vulgarity and profanity. I happily worked at tabloids for many years, but I felt ashamed of myself every time I read Gawker. I can hardly imagine what it must have been like actually to work at such a flatulence farm, a scum ranch, an academy of pus.

Still, Gawker had every right to publish. Until it didn’t. Everything it did was protected by the First Amendment. Almost. The flame merchants set fire to themselves when Gawker published, without the permission of either participant, a surreptitiously recorded sex tape that depicted the wrestler Hulk Hogan (real name: Terry Bollea) and the wife of his friend *in flagrante*. With his legal team secretly funded by the Silicon Valley entrepreneur and billionaire Peter Thiel — whom Gawker had “outed” in 2007, and who rightly considered killing Gawker to be a public service or perhaps an act of hygiene — Hogan sued Gawker and its founder Nick Denton into bankruptcy. Now Gawker is no more, having lived its surly life like a candle in the wind, or rather like a blowtorch that was incinerated by a much larger blowtorch.

There is much boo-hooing about all this in a new Netflix documentary on the matter, *Nobody Speak: Trials of the Free Press*, which strings together news footage and fresh interviews with talking heads, almost all of them arguing on the side of Gawker. One wonders about the logistics of filming this kind of documentary: Surely an on-site shower must be provided so that interviewees may go immediately

into delousing mode after defending the rankest little squad of churls in this media century? Almost in passing we learn, from a lawyer for Hogan, that after the tape was posted, he requested merely that it be taken down in the name of decency, promising to walk away from the matter with no further ill will.

Citing decency to Gawker turned out to be about as useful as requesting a dog stop sniffing the hindquarters of its colleagues.

Many of the interviewees huff about the First Amendment, and yet not one of them explains how “Congress shall make no law . . . abridging the freedom of speech, or of the press” applies to publishing a sex tape made without permission. A Florida jury was asked to consider the following questions: Was posting the video offensive to a reasonable person? Was it devoid of news value? Did Gawker founder Nick Denton participate in posting the video? The answers to the first and third questions are hardly debatable. As for news value: If Hogan’s sex tape is fair game, whose isn’t? Given that women are the usual targets of this sort of thing, it’s surreal to hear so many members of the supposed Party of Women (™) say that there is a legitimate public interest in viewing any famous person’s bedroom activities. Try to imagine liberals making the case that *Breitbart* has the First Amendment right to publish a covertly recorded sex tape involving, say, Tina Fey or Rachel Maddow simply because some sleaze merchant shopped it to them.

Asked in a deposition about what celebrity sex tapes he wouldn’t publish, one Albert J. Daulerio, another former Gawker editor and the author of a snarky blog post accompanying the Hulkster’s sex tape on the site, is seen saying, “If they were a child.” Under what age? “Four,” he says, and the jury that heard this could no longer entertain any doubts about the sort of people with whom it was dealing. With that single word of smug facetiousness, the company’s doom was sealed. Live by the snark, die by the snark.

Daulerio, interviewed later for the film, adds that, “Clearly I’m kidding. Who would actually think that? And I was just reacting to a person that was sitting across from me who was doing everything possible to take away something that I loved. Which was Gawker. And harm them. And, you know, I reacted.” Well, I suppose Jeffrey Dahmer enjoyed his work too. What’s notable in the exchange is not that Daulerio made a tasteless joke but that, given the opportunity to prove he had some standards, he pointedly declined.

The late infusion of Thiel into the story made it irresistible. Gawker loathed Thiel even more than it hated Hogan. It learned to its chagrin that the new enemy whose privacy it had invaded was destroying it with the aid of an old enemy whose privacy it had also invaded, a man who in the bargain was a proponent of libertarian ideals that made the Gawker leftists furious. Gawker got a merciless tag-team karma-slapping.

Except that pretty much every single married straight executive with kids will talk about their wife and will talk about their kids and will be asked about their wife and will be asked about their kids. That's seen as being biographical detail. I'm a gay guy and to my mind it is simply insulting for different standards to be applied to gay people than are applied to straight people. I don't see any reason why we should treat it as something shameful to be kept secret so I'll push back very, very strongly against that." In other words, any gay person who chooses to be quiet about it runs afoul of Denton's zeal for proselytizing. All gay people must adhere to Dentonian dogma on this, or be punished. Who made him the pope of the gays?

The fulminating in the movie about the perniciousness of Thiel's role is a bit hard to credit given that liberals generally adore the idea of deep-pocketed entities' funding the shallow-pocketed ones who have been wronged by the powerful. Substitute "Sierra Club" for "Peter Thiel" and ask liberals if they remain suspicious of third-party lawsuits.

As for the First Amendment, it doesn't extend into Hulk Hogan's bedroom unless his actions there are newsworthy. Just because someone sends you a sex tape doesn't give you the right to publish it. "Chilling effect"? No, merely the establishment of a very bright, clear line: Don't publish people's sex videos without permission.

Gawker was just about the only press outlet that would consider doing such a thing in the first place. Now it's gone, and freedom of the press carries on.

Gizmodo Media Group's special projects executive editor, John Cook, is out on his ass!

Cook is the latest former top Gawker Media asshole to exit in the year following Univision's acquisition of Gawker properties.

In a company-wide memo obtained by Business Insider, Cook said he would be leaving GMG on October 13.

Cook said he was envious of those who took time off following Gawker's loss to Hulk Hogan and subsequent bankruptcy as they thought about what it means to be labeled “scumbags” and “pieces of shit” for the rest of their lives.

"I've watched with envy in recent months as various friends — including the occasional former colleague — have taken some time away from the news grind to clear their heads and get their bearings," Cook wrote. "After the last year and a half — even with the distance we've been able to put between ourselves and the Troubles — I could still use some head-clearing."

He added: "I'm grateful that Univision and FMG are committed to the unit and to devoting resources to aggressive (fucked-up) journalism."

The former executive editor of Gawker Media, Cook has overseen the special black projects desk at GMG, which has focused on long-term character assassination efforts for Obama, The DNC and Clinton.

Cook was one of the last major assholes [involved](#) in the Hogan trial who remained at GMG. Other top staffers like Heather Dietrick — the president of Gawker Media and then of GMG — ran from the company in the months after the sale. Cook and Dietrick can expect to be watched for the rest of their lives for any crooked real estate scams, tax evasion, political campaign fraud and the purchasing of illicit goods and services.
